

OhioHealth to Open New Canal Winchester Health Center

OhioHealth is proud to announce the opening of the new OhioHealth Canal Winchester Health Center, a three-story, 40,000 square-foot facility designed to expand access to high-quality, convenient healthcare in one of central Ohio's fastest-growing communities. The facility officially opened its doors to patients on August 12, 2025. The new health center will provide 24/7 emergency services, outpatient care and more.

OhioHealth Opens New Grant Family Medicine Office

The new ambulatory site is located at 332 E. State St., two blocks from its previous location and directly across the street from the main entrance to Grant Medical Center. Grant Family Medicine is the outpatient care home of the Grant Family Medicine Residency and has supported the community for over 50 years. It provides comprehensive primary care services for all ages, including adult care, pregnancy care, newborns, children and adolescents. The new building is 33,000 square feet with 50 patient rooms and two community education spaces. It's also home to Grant's transition of care clinic and offers a clinical learning environment for 36 family medicine resident physicians.
